Course Number Changes in CIM				Cari Heizer explained that when a change is made in the Course Inventory Management (CIM) system to the prefix, course number, or adding or deleting an "R" it deletes what is called the ecosystem, which is a listing of all catalog pages or other courses that reference the course. Preserving the ecosystem is vital to making sure changes are made in every place they need to be made. She distributed an instruction sheet detailing what needed to be done when making any course number change and asked everyone present to distribute the information to department chairs in their colleges.

There was extensive discussion about concerns and potential problems, including:  Problem of DSU students transferring to another institution being able to meet that institution's diversity requirement – courses would be tagged on the back end.  Have learning outcomes already been approved for all affected courses? Not all yet, but majority.  Will each course go through approval process? No it is a structural change approved by the GE committee.  Each course description for courses that are not currently GLOCUP will need to be changed to include diversity component.  Problem of transfer students receiving GLOCUP credit for courses from other institutions. All courses will have to be articulated for GLOCUP.  What are advantages? There are lots of courses that double-dip, so there is in effect a short path or long path. This would create one path.  Problem of catalog rights.  If GLOCUP bucket is eliminated there is no way for Degree Works to track it and no way to enforce it for graduation.  Transparency to students is important.  Simplifies because if students take all other GE requirements, GLOCUP requirement is met.

Regarding program proposals, should UCC be providing qualitative feedback instead of sending votes to AC?</li> <li>c. Specifically from our last meeting, what would a policy of potential program re-integration look like?</li> </ul>		Brent requested feedback on three questions. His first concern was whether UCC should be giving AC a vote or feedback about program proposals. Ideas discussed included:  • There should be two-way communication with AC so UCC knows when AC vetoes something approved by UCC  • After UCC approved fees the process was changed so fees cannot be implemented until approved by the Board of Trustees  • UCC is not qualified to judge programs as a whole; it should limit its analysis to curriculum  • Faculty needs shared governance and to feel like they have a voice in the program process  • The Provost is empowering department chairs with regard to budget, so committee members should have more understanding of program budgetary concerns  • There is a hierarchal chain of command—a lower level cannot dictate to a higher level  • UCC should just judge the curricular strength of a
